SUSPENDED STUDENTS: A former student who is on academic suspension must also complete an application for reinstatement. These may be obtained from the Registrar's Office.

TRANSCRIPTS: Returning students who have registered at any other Institution after leaving the University of Nevada, Las Vegas must supply transcripts from each institution attended, whether or not credit was earned. Transcripts must be received in the Registrar's Office directly from the issuing institution. Hand carried transcripts are not acceptable.
